N ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAKELAND. FLORIDA. RELATING TO THE CREATION OF DEVELOPMENT SEVEN COMMUNITY DISTRICTS: ESTABLISHING WILLIAMS COMMUNITY **DEVELOPMEN** DISTRICT NUMBER ONE. WILLIAMS COMMUNIT DEVELOPMENT DISTRICT NUMBER WILLIAMS TWO. COMMUNITY DEVELOPMENT DISTRICT NUMBER THREE. WILLIAMS COMMUNITY DEVELOPMENT DISTRICT NUMBER FOUR, WILLIAMS COMMUNITY DEVELOPMENT DISTRICT NUMBER FIVE. WILLIAMS COMMUNITY DEVELOPMENT DISTRICT NUMBER SIX. AND WILLIAMS COMMUNITY DEVELOPMENT DISTRICT NUMBER SEVEN PURSUANT TO CHAPTER 190, FLORIDA STATUTES; PROVIDING A TITLE; PROVIDING FINDINGS: CREATING AND NAMING THE DISTRICTS; DESCRIBING THE EXTERNAL BOUNDARIES OF THE DISTRICTS: DESCRIBING THE FUNCTIONS AND POWERS OF THE DISTRICTS; CONSENTING TO THE USE OF SPECIAL POWERS BY THE DISTRICTS; DESIGNATING FIVE PERSONS TO SERVE AS THE INITIAL MEMBERS OF THE DISTRICTS' BOARD OF SUPERVISORS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Petitioner is a New Jersey corporation authorized to conduct

business in the State of Florida whose principal place of business is One

Williams Center, Suite 4100, Mail Drop 45-4, Tulsa, OK 74172; and

WHEREAS, all interested persons and affected units of general purpose

local government were afforded an opportunity to present oral and written

comments on the Petition at a duly noticed public hearing conducted by the City

on June 18, 2007; and

WHEREAS, upon consideration of the record established at that hearing duly noticed, the City finds as follows:

(1) The statements within the Petition were true and correct; and

(2) Establishment of the seven Districts by this Ordinance is subject to and not inconsistent with the local Comprehensive Plan of the City and with the State Comprehensive Plan; and,

(3) The area of the land within each of the seven Districts is of sufficient size, is sufficiently compact, and is sufficiently contiguous to be developed as one functional, interrelated community; and,

(4) Each of the seven Districts is the best alternative available for delivering community development services and facilities to the area proposed to be serviced by that District; and,

(5) The services and facilities of each of the seven Districts will not be incompatible with the capacity and uses of existing local and regional community development services and facilities; and,

(6) The area to be served by each of the seven Districts is amenable to separate special district governance; and

WHEREAS, establishment of each of the seven Districts will constitute a timely, efficient, effective, responsive and economic way to deliver community development services in the area described in the Petition; and,

WHEREAS, the Petitioner has requested the City for consent to exercise one or more of the special powers granted by charter in Section 190.012(2), Florida Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAKELAND, FLORIDA, THAT:

SECTION 1. **TITLE**. This Ordinance shall be known and may be cited as the "Williams Community Development Districts Establishment Ordinance."

SECTION 2. COMMISSION FINDINGS. The Commission findings set forth in the recitals to this Ordinance are hereby incorporated in this Ordinance.

SECTION 3. AUTHORITY. This Ordinance is adopted in compliance with and pursuant to the Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes (2006).

SECTION 4. CREATION OF SEVEN DISTRICTS; DISTRICT NAMES. There are hereby created seven community development districts situated entirely within the incorporated boundaries of the City of Lakeland, Florida, and these districts shall be known as follows:

- (1) Williams Community Development District Number One
- (2) Williams Community Development District Number Two
- (3) Williams Community Development District Number Three
- (4) Williams Community Development District Number Four
- (5) Williams Community Development District Number Five
- (6) Williams Community Development District Number Six
- (7) Williams Community Development District Number Seven

<u>SECTION 5.</u> <u>EXTERNAL BOUNDARIES OF THE DISTRICTS</u>. The seven Districts' external boundaries are described and depicted in Exhibit "A" attached hereto.

SECTION 6. FUNCTIONS AND POWERS. Each of the seven Districts is limited to the performance of those powers and functions as described in Chapter 190, Florida Statutes. Consent is also hereby given, as provided in Section 190.012(2), Florida Statutes (2006), to each of the District Boards so long as it is in compliance with and subject to the City of Lakeland Comprehensive Plan and subject to the regulatory jurisdiction and permitting authority of all applicable other ordinances and regulations of the City, the power to plan, establish, acquire, construct or reconstruct, enlarge or extend, equip, operate, and maintain additional systems and facilities for parks and facilities for indoor and outdoor recreational, cultural and educational uses, fire prevention and control, including related buildings and equipment, school buildings and related structures, security, including but not limited to personnel and equipment, mosquito and anthropods of public health importance control, and waste collection and disposal. In the exercise of its powers, each of the seven Districts shall comply with all applicable governmental laws, rules, regulations and policies including, but not limited to, all City ordinances and policies governing land planning and permitting of the development to be served by the District. The seven Districts shall not have any zoning or permitting powers governing land development or the use of land. No debt or obligation of any of the Districts shall constitute a burden on any local general purpose government.

SECTION 7. **BOARD OF SUPERVISORS**. The five persons designated to serve as initial members of each of the seven Districts' Board of Supervisors are as follows:

<u>SECTION 8</u>. <u>SEVERABILITY</u>. If any portion or section of this Ordinance is held or declared to be unconstitutional, inoperative or void, such holding shall not affect the remaining sections or portions of this Ordinance. If this Ordinance or any provision hereof shall be held to be inapplicable to any person, property or circumstance, such holdings shall not affect its applicability to any other person, property, or circumstance.

SECTION 9. EFFECTIVE DATE. This Ordinance shall become effective immediately upon its passage.
